The LATTs study was initiated and developed in 1996 at two meetings of SASHTO personnel convened by former Mississippi DOT Executive Director Dr. Robert L. Robinson, and attended by then FHWA Administrator Rodney E. Slater. The FHWA agreed to provide significant funding, and initiate a scope of work and prospectus; the Mississippi DOT agreed to manage the work as a pooled fund study; and the other SASHTO States agreed to provide funding and working level guidance during the study.
